Megan Manual and Michelle Swearingen, Board of Developmental Disabilities, were present for a work session to discuss budget matters with the Board.

Ms. Swearingen presented the expenditures to the Board and explained that they have complied with the Commissioners' request to expand services to those in need through Warren County due to the amount of carryover funds from the taxpayers that was being collected. She then discussed the numerous budget cuts from the State and Federal government along with the increase in expenditures which will result in the need to collect the full 4 mil levy amount in 2012 rather than the reduced amount.

There was discussion relative to the need to collect the additional 2 mils approved by the voters of Warren County.

Mrs. South stated that, upon consideration of the numbers presented, she is inclined to support the collection of the full millage.

Commissioner Young stated his opinion that if the Board accepts their recommendation to collect the full millage, the Developmental Disabilities Board should budget accordingly and not expect the voters to turn around in two years and approve a new levy.

Upon discussion, the Board thanked Ms. Manual and Ms. Swearingen for the great job they do for these clients and for the community.

On motion, upon unanimous call of the roll, the Board entered into executive session at 10:10 a.m. to discuss personnel matters within the Water and Sewer Department pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 10:28 a.m.

Mike Yetter, Zoning Supervisor, was present along with Stan Williams, RPC Executive Director, Fred Grimm, Rural Zoning Commission Board member, and Bruce McGary, Assistant Prosecutor, for a final work session to discuss the proposed Warren County Rural Zoning Code Re-write.
