Eugene Rose, Warren County Community Services, was present to present a reimbursement check to the Board in the amount of \$25,000 to repay the loan provided through the Community Housing Improvement Program funds for the rehabilitation of a donated house.

Mr. Rose stated that the house and property was a foreclosure owned by the bank and donated to Community Services/Balanced Housing. He stated that the borrowed program income money was used to purchase material and the labor supplied by the Warren County Career Center students to rehab the home.

Mr. Rose stated that once the construction was completed, the house was placed on the market for sale and a qualified buyer that meets the low to moderate income guidelines now has the property under contract. He then added that the buyer meets the program income guidelines and has been living in his parents' basement in order to save enough money to pay cash for the property.

There was discussion relative to the need for financial literacy in today's environment and upon request from Commissioner Young, a future work session will be scheduled between Community Services, Warren County Human Services and OhioMeansJobs Warren County in order to help foster that environment in Warren County.

Commissioner Young stated his desire for Warren County to be known for their ability to teach a low to moderate income family how to become rich.

Adam Jones, Workforce Investment Board Executive Director, was present along with Karen Whittamore, OhioMeansJobs Warren County Director, and Lauren Cavanaugh, Human Services Director, for a work session to discuss the newly mandated Comprehensive Case Management.

Mr. Jones reviewed the requirements from the State of Ohio relative to the new mandate and stated that Warren County must select a lead agency prior to May 15, 2016, for an effective date of July 1, 2016.

Commissioner South stated her opinion that Human Services does a great job with assistance but it is the duty of OhioMeansJobs Warren County to help find jobs for all those in need. She then stated her recommendation to select OhioMeansJobs Warren County as the lead agency relative to Comprehensive Case Management.

Upon discussion, the Board resolved (Resolution #16-0569) to designate OhioMeansJobs Warren County as the lead agency responsible for administering the Comprehensive Case Management and Employment Program effective July 1, 2016.

On motion, upon unanimous call of the roll, the Board entered into executive session at 10:03 a.m. to discuss personnel matters relative to disciplinary action within Human Services and hiring within the Water and Sewer Department and Facilities Management pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 12:09 p.m.
