DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Dr. George Sehi, Executive Director for University Relations at Warren County Educational Service Center, was present to introduce Dr. Ande Durojaiye, Vice President and Dean of Miami University's Regional campuses. Dr. Durojaiye presented the attached PowerPoint Presentation outlining two of Miami University's Regional campus initiatives. The first initiative being the College Credit Plus Program and the second being the Work Plus Program.

Matt Schnipke, Economic Development Director, and Susanne Mason, Director of Grants Administration, were present for a work session to request authorization to submit an application for the Building Demolition and Site Revitalization Grant Program through the Ohio Department of Development. Mr. Schnipke stated it is the second grant for the demolition of blighted, abandoned, or vacant structures. He then stated it would be a \$500,000 match free grant.

Mr. Schnipke discussed how Brownfield sites are not eligible for the grant, however we have 17 properties eligible for the grant including the old Warren County Jail. He stated that preliminary estimates are showing we will come in below the \$500,000 amount so the thought is to work

with Trevor Hearn, Director of Facilities Management, to include the old Warren County Jail building.

Commissioner Jones questioned if we would be able to fund all the sites sought out and then the remaining funds would go towards the demolition of the jail. She also questioned if we have an estimate of cost for the demolition of the jail.

Mr. Schnipke stated they were working on getting an estimate from Mr. Hearn.

Mrs. Mason stated Mr. Hearn's original estimate was thought to be between \$200,000 and \$300,000.

There was discussion regarding being locked into the grant once we apply, if we must draw down all the funds given to us, and how the money can be shifted between projects.

Upon discussion, the Board resolved (Resolution 22-0294) to approve and authorize the Warren County Port Authority to apply to the Ohio Department of Development for the Building Demolition and Site Revitalization Grant Program.

Tiffany Zindel, County Administrator, stated that Governor Mike DeWine signed House Bill 51, a temporary order to allow the Board to meet virtually through June 30, 2022. She stated she could work with Bruce McGary, Assistant Prosecutor to prepare a resolution for next week.

There was discussion regarding the status of House Bill 51 and if it was COVID related. Mrs. Zindel stated the bill was effective immediately and the County Commissioners Association of Ohio bulletin mentioned the continued authority of the COVID pandemic.

The Board stated their agreement for the resolution to be approved next week and discussed various meeting options.

Upon motion the meeting was adjourned.
