WHEREAS, the bid specification included a request for an alternate bid relative to the type of asphalt process (SAMI Process versus Asphalt 1.5" overlay) being used for the project; and

WHEREAS, the Project Engineer reviewed the bids and recommends awarding the bid to J.K. Meurer Corp for the alternate bid submitted (Asphalt 1.5" overlay); and

WHEREAS, Jerry Haddix, Grants Coordinator has determined that J.K. Meurer Corp is the low bidder for the alternate bid of \$63,000.00; and

WHEREAS, Mr. Haddix further finds that J.K. Meurer Corp did not complete several Ohio Department of Development forms in the bid document or provide their certificate of workers compensation; and

INVITATION TO BIDDERS

Separate sealed bids for the FY2008 Village of Morrow Street Improvements CDBG Project Re-Bid will be received by the Warren County Board of Commissioners at the Office of the Warren County Commissioners, 406 Justice Drive, Lebanon, Ohio 45036, until 10:30 a.m. on September 1, 2009, and then at said time publicly opened and read aloud.

Bid documents and specifications may be obtained at the Warren County Office of Grants Administration upon payment of \$20.00. None of these costs are refundable.

A bid guaranty, as required by Ohio Revised Code, Section 153.54, shall accompany each proposal submitted, as follows:

1. A Certified check, cashiers check, or letter of credit equal to ten (10) percent of the bid. A letter of credit may only be revocable by the Owner. Upon entering into a contract with the Owner, the contractor must file a performance bond for the amount of the contract, and the bid guaranty will then be returned to the successful and unsuccessful bidders upon contract execution.

OR

2. A form of bid guaranty bond (attached) for the full amount of the bid. Such bond is retained for the successful bidder, but returned to unsuccessful bidders after the contract is executed.

Bid Bonds shall be accompanied by Proof of Authority of the official or agent signing the bond.

No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

All bids shall be properly signed by an authorized representative of the bidder.

Warren County reserves the right to reject any or all bids submitted, to waive any irregularities in bids, and enter into a contract with the Bidder who in Warren County's consideration offered the lowest and best bid.
