On Friday, October 12, the President of the United States (POTUS) made a stop at the Warren County Fairgrounds in support of Republican nominees running for office in Ohio. Warren County Emergency Services was proud to participate in this extensive collaborative effort. We provided staff for operational communications, situational awareness, and emergency planning.


Throughout the week, EMA ran through scenarios to pre-plan for the visit and any other identifiable threats and hazards. This pre-planning effort resulted in the creation of event action plans, identification of logistical resources needed, assignment of key personnel to EOC positions, and creation of EOC and amateur radio stand-by teams that were readily available for full activation.



We collaborated with

the Regional Operations Center in Hamilton County, the Fusion Center, and Fairground's Command to gather real-time situational awareness, monitor multiple video and audio feeds for threats and hazards, and shared real-time data related to the event at the fairgrounds. EMA was able to run tabletop exercises to train EOC members for future events.

WCDES would like to thank the Warren County Sheriff's Office, Telecom, Warren County CERT, and the Warren County Amateur Radio Clubs for their assistance and collaboration in the pre-planning and execution of EOC operations for the Presidential visit to the County.




# **Dispatcher Recognized For Giving Life Saving Instructions**By: Melissa Bour

On June 4, 2018 at 10:06 pm, Dispatcher, Amberlee Applegate answered a 911 call where she gave CPR instructions and ultimately saved Charles Evan's life. On October 12th the caller and her husband came by to thank Amber and to give her a very nice card and gift card. It's the first time in the 18 years that I have been here, that we actually had the chance to meet someone who's life we've saved! Dispatchers very seldom get recognized or have closure on calls that they answer. Great job Amber!







# Did You Know? Field Amputation By: Brian Holtel

A doctor rushing to the scene of a terrible accident that requires a field amputation seems like part of a plotline for an action movie or medical dramas. However, this is a resource that is available locally, and has even been used recently. In fact, both Premier and Kettering Health Networks offer these teams.

Two years ago, Kettering launched their Surgical Emergency Response Team (SERT), based at Kettering Medical Center's level II trauma center. The team consists of a surgeon, physician assistant, surgical technician, and other hospital staff and provides advanced surgical care at the scene of an accident for someone who cannot be quickly extricated and transported to a hospital for treatment. Premier Health Network recently formalized a Physician Scene Response (PSR) program, based at Miami Valley Hospital's level I trauma center. When activated, a physician, along with field amputation equipment and blood products will be transported directly to the scene via CareFlight helicopter or MICU.

On September 1<sup>st</sup>, a surgical team responded to a semi-crash on I-70 near the Dayton airport to amputate the leg of the driver that was impaled by a piece of metal below the knee and was unable to be extricated.

A Miami Valley's PSR may also be requested for a scene response in the event of an MCI or other disaster that would benefit from a physician at the scene. This request is made through the CareFlight Communications Center. Activation for Kettering SERT is done by contacting the KMC squad phone number.

This type of response is certainly not one that is used routinely but is a valuable resource to have available in dire situations.

All law enforcement has the ability to check the BMV for Titles using the Automated Titling Processing System (ATPS) database. This database contains information on all businesses and individuals who have a vehicle title(s) registered within the State of Ohio.

Below is what you can run and what information you will need in order to check the database:

### **NWS Introduces a New Winter Warning**

Beginning November 1, 2018 the National Weather Service (NWS) Wilmington will be able to issue a new warning called a **Snow Squall Warning**.

Snow squalls are characterized by intense short-lived bursts of heavy snow that lead to near-white out conditions and are often accompanied by gusty winds and plummeting temperatures. Snow squalls are not extremely common in our area, but they do occur and pose a serious threat to personal safety and property and could lead to high speed accidents with large pileups that result in injuries and fatalities.

Snow Squall Warnings will be short-fused and focused on distinct areas (like tornado and severe thunderstorm warnings). At this time, the Emergency Alert System (EAS) and Wireless Emergency Alerts (WEAs) will not be activated when Snow Squall Warnings are issued.
