






#### PUBLIC OUTREACH—STOP THE BLEED

Warren County Communications Center, Training Coordinator Samantha Hall worked in conjunction with Clearcreek Fire District and Kettering Health Network to educate 1st graders at Clearcreek Elementary School on how to Stop the Bleed. We discussed calling 911, what types of questions we will ask, and the importance of knowing your address. After breaking into small groups, we taught them how to apply direct pressure to a bleeding injury and how to pack larger wounds with packing gauze. The final topic was the use of a tourniquet. The students learned what a tourniquet is and how it works to stop bleeding. They then got to apply the tourniquet on a wounded leg simulaid. This is a wonderful public outreach program to teach our new generation, lifesaving skills.

# Duke Energy Hosts Storm School & Donates to County EMAs

#### **Storm School Recap**

Warren County EMA and other EMAs from the region attended Duke Energy's Storm School on May 10th, 2023. This regional, free event is designed for first responders and emergency management partners in the Southwest Ohio and Northern Kentucky region. Presentations about meteorology and regional weather patterns, storm preparation and restoration, grid resiliency, and vegetation management were shared to demonstrate how Duke Energy makes decisions and works collaboratively to restore power after a storm . This information is beneficial to help

understand power outages and provide education to those

impacted by an outage.

The Storm School wrapped up with a live line safety demonstration. During this demonstration, Duke Energy personnel showed the dangers of live power lines. It is especially important to always treat every power line, even downed lines, as if they are live and dangerous!

Duke Energy is looking to host the next Storm School in February of 2024. Warren County EMA will share more information when it becomes available.

#### **Duke Energy Foundation Grant**

During the Storm School, Duke Energy presented several Southwest Ohio and Northern Kentucky County EMAs with a grant to help improve emergency management programs and systems.

All Southwest Ohio EMAs have a great working relationship with Duke Energy, exercising on the importance of the power grid, staging vital equipment before storms occur, and coordinating restoration of critical power services.

**LOCATES**: The locate restriction due to the potential for an outbreak of COVID-19 inside jails has been lifted. Agencies shall resume placing locates on subjects located within the PUR/Extradition Limitation in accordance with LEADS policy.

National Instant Criminal Background Check System (NICS) Section

Expanded Outreach for Potential Firearm Transfers
to Individuals Under the Age of Twenty-one



#### Purpose of Outreach

Due to the passage of the Bipartisan Safer Communities Act of 2022 (hereinafter "Act"), public law 117-159, the NICS Section will conduct additional outreach for NICS background checks initiated at a federal firearms licensee when the potential firearm transferee is under the age of 21. The additional outreach is to determine if the person has Juvenile criminal/delinquency information or juvenile mental health adjudications/commitments that may be disqualifying for the receipt or possession of firearms under subsection (d) of Title 18, United States Code, section 922. The Act directs NICS to immediately contact the criminal history repository or juvenile justice information system, as well as the appropriate state custodian of mental health adjudication information in which the person resides. In addition, the legislation requires NICS to contact local law enforcement agencies of the jurisdiction in which the person resides.

#### Method of Outreach

When a NICS check is initiated for a potential firearm transferee under the age of 21, the NICS Section will send a request (sample provided) to the identified points of contact requesting relevant juvenile information. Outreach to the points of contact identified for the potential juvenile criminal/delinquency information and the juvenile mental health adjudication/commitment information will be conducted through the established method as directed by the individual agency (i.e. e-mail). Outreach to local law enforcement for juvenile information will be made to the appropriate law enforcement agency based on the city, state, county, and zip code combination of the address provided by the individual to the firearms dealer. These requests will be delivered via a National Crime Information Center (NCIC) \$.H.U21 unsolicited message.
